1. If pool is outdoors, is the pool yard enclosure at least 4 feet high? Yes No
2. Are walls of buildings used as part of the pool yard enclosure? Yes No

 - (1) Do Single doors have self-closing and self-latching devices? Yes No
 - (2) Do French doors have one door with dead bolt capable of insertion into door jamb above door and one into floor, and the other door with self-latching lock? Yes No
